## SUPPLEMENTARY REGULATIONS

- 1 The Green Belt Motor Club will organise and promote an Interclub permit Sprint on Sunday 20th July 2025 at North Weald Airfield, Essex.
2. The meeting will be held under the National Competition Rules of Motorsport UK (incorporating the provisions of the International Sporting Code of the FIA) and these Supplementary Regulations and official instructions issued by the organising club.
3. Motorsport UK Permit Number 203026
4. The event is open to fully elected members of the Organising Club, championship contenders in the 2025 **GTM** AEMC/ASEMC Speed Championship, 2025 ACSMC Speed Championship Sponsored by Hamilton Motorsport Ltd, the GF & Co Borough 19 MC Speed Championship 2025, the Sevenoaks & DMC Insite Graphics Speed League 2025, the Sevenoaks & DMC Insite Graphics Speed League Historic Car Championship 2025 and members of clubs belonging to the following associations:- Association of Eastern Motor Clubs, Association of Central Southern Motor Clubs and the Welsh Association Motor Clubs.
5. All competitors and drivers must have a valid Competition Licence, club membership card, championship registration card where appropriate and produce them when required.
6. The event is a qualifying round in the 2025 **GTM** AEMC/ASEMC Speed Championship, 2025 ACSMC Speed Championship Sponsored by Hamilton Motorsport Ltd, the GF & Co Borough 19 MC Speed Championship 2025, the Sevenoaks & DMC Insite Graphics Speed League 2025, the Sevenoaks & DMC Insite Graphics Speed League Historic Car Championship 2025.
7. The programme of the meeting will be:  
Paddock opens at 07.45  
Convoy runs, if needed, start at 09.30  
Practising starts at 10.00  
First timed runs start immediately following practice
8. The length of the course is approximately 1700m and consists of left and right hand bends on tarmac and concrete surfaces.

9. The event will contain the following categories and classes:

**A. Standard Cars (NCR Ch. 14 App.4 Art.13.1), Road Cars (Series Production, NCR Ch. 14 App.4 Art.14.1.1) and Road Cars (Specialist Production, NCR Ch. 14 App.4 Art.14.1.2)**

**Excluding cars in Appendix 1 below.**

1. 'Standard Cars': up to 1600cc, 2wd only, List 1A tyres (NCR Ch. 8 App.4)
2. 'Standard Cars': from 1601cc to 2000cc, 2wd only, List 1A tyres (NCR Ch. 8 App.4)
- 2A. Junior Sprint (14 to 16 years), see NCR Ch. 14 App.2 Art.1.9
- 2B. Intro-Class, see NCR Ch. 14 App.2 Art.1.12 (RS Clubman licence acceptable)  
'Standard Cars': up to 2000cc, 2wd only, List 1A tyres (NCR Ch. 8 App.4)
3. Up to 1600cc, 2wd only, List 1A or 1B tyres (NCR Ch. 8 App.4)
4. From 1601cc to 2300cc, 2wd only, List 1A or 1B tyres (NCR Ch. 8 App.4)
5. 2301cc and over, 2wd only, List 1A or 1B tyres (NCR Ch. 8 App.4)
6. 4wd of all engine capacities, with List 1A or 1B tyres (NCR Ch. 8 App.4).

**Road-Going Kit Type and Replica Cars (Examples are included in Appendix 1 below)**

7. Up to 1800cc, excluding Motorcycle-engined cars. List 1A or 1B tyres (NCR Ch. 8 App.4)
8. Over 1800cc, including Motorcycle-engined cars, List 1A or 1B tyres (NCR Ch. 8 App.4)

**B. Modified Series /Specialist Production (NCR Ch. 14 App.4 Art.15.1.1/15.1.3), Rally Cars conforming to NCR Ch. 13 App.16 & 17 and Rallycross Cars & derivatives conforming to NCR Ch. 13 App.9**

**Excluding those listed in Appendix 1 below:**

9. Up to 1400cc
10. From 1401cc to 2000cc
11. 2001cc and over

**Kit Type and Replica Cars (Examples are included in Appendix 1 below)**

12. Up to 2000cc
13. 2001cc and over plus all motorcycle engaged cars

**C. Sports Libre Cars (NCR Ch. 14 App.4 Art.16.1)**

14. Sports Libre Cars up to 1800cc, motorcycle engaged cars up to 1100cc
15. Sports Libre Cars over 1800cc, motorcycle engaged cars over 1100cc.

**D. Racing Cars (NCR Ch. 14 App.4 Art.16.1) and Hill Climb Super Sports Cars**

16. Up to 1100cc plus racing cars conforming to 'Formula Ford' specifications
17. 1101cc and over

No electric vehicles are allowed to take part in this event.

**Appendix 1 – Road-Going Kit Type and Replica Cars**

Two seater cars such as Caterham, Westfield, Sylva, Fisher and Lotus 7, Elise, Exige and 340R, Vauxhall 220, X-bow- and similar types/ derivatives.

**Appendix 2 – Standard Car Class**

'Standard Cars' are as defined in NCR Ch. 14 App.4 Art.13.1. 'Standard Car' definition applies to those cars made after 01/01/2000.

**Note 1.** Engine capacity increase/decrease factors:

- a. Forced induction, an increase of 40%, except for 'Standard Cars' where an increase of 70% should be applied.
- b. Rotary engined cars, an increase of 50% on the real capacity.

**Note 2.** Any Driver competing in a Racing or Sports Libre car of more than 1100cc, or equivalent forced induction, with the exception of a pre'1994 Formula Ford 1600 in compliance with the period Ford regulations, must hold a RS National (*NCR Ch. 6 annexe A Chart 2*) or Race National Licence, unless the car is currently licensed for use on the public highway and competes in the event in a road-legal condition.

In the event of a dispute concerning the compliance of a vehicle to the regulations for the event the onus will be on the competitor to prove the compliance to the organisers. Road going cars must be taxed, insured and fully MOT tested (where necessary) and road legal in all respects. Documentation must be available at signing on if verification is requested or on the date of the event.

*For both safety and environmental concerns, vehicles must not be left unattended under any circumstances when the engine is running. Single-use plastic tyre wrapping is prohibited and must be replaced with reusable environmental alternatives.*

10. **Reminders**

- Clothing to **NCR Ch. 14 App.2 Art.4.1 - 4.5**
- Identification numbers must be shown on BOTH SIDES of the car, **NCR Ch. 14 App.2 Art.3.1**, and Competition numbers must be covered or removed at all times whilst driving on the public highway, **NCR Ch. 14 App.2 Art.3.2**.
- Standard Cars and Road Cars must comply with seat belt rules **NCR Ch. 7 App.4 Art.6** with the exception of Junior Sprint Competitors who must comply with **NCR Ch. 7 App.4 Art.7** as a minimum, **NCR Ch. 14 App.4 Art.2.6**.
- Towing point(s) of adequate strength and size are mandatory. They must be clearly identified and suitably marked using a contrasting colour and be accessible to the front and rear of the vehicle, **NCR Ch. 14 App.4 Art.2.11**.

11. All other National Competition Rules of Motorsport UK apply as written except for the following which are modified:

- **NCR Ch. 14 App.2 Art.5.1/5.2** A driver may only be permitted a maximum of two entries and these must be in different classes. The same car may not be entered to compete for the same award more than twice, and then only provided it is driven by different drivers.
- **NCR Ch. 14 App.3 Art.1.1** Practicing and tyre warming is forbidden as there is no designated area at this venue. Anyone caught carrying out such activity may be excluded from the meeting.
- **NCR Ch. 14 App.3 Art.1.10(a)** applies when a red signal is shown.
- **NCR Ch. 14 App.3 Art.3.1** The number of runs will be determined on the day, the fastest run to count for the results.
- **NCR Ch. 14 App.3 Art.3.4** A penalty of 5 seconds will be applied for striking a course penalty marker.
- **NCR Ch. 14 App.3 Art.3.9** Judges of Fact will be appointed for (a) and (b).

12. Cars will start singly. The starting signal will be a GREEN light. Timing will be automatic and activated by light beam (**NCR Ch. 14 App.1 Art.4.7**). The attention of competitors in all classes is particularly drawn to **NCR Ch. 14 App.4 Art.11.1**. Any vehicle not fitted with a timing strut in accordance with this regulation WILL NOT BE TIMED. The finish line will be indicated by a FINISH board and a CHEQUERED flag.

13. Competitors will have the opportunity for one timed practice run. All competitors will also have the opportunity of a convoy run and all competitors may walk the course prior to the practice. There will be at least three timed runs which count to the results with the fastest (including any penalties) time counting to the awards.

14. The entry list opens on publication of these regulations and closes finally on Tuesday 15th July 2025.

The entry fee is £110.00, or £99.00 for Anglia Motor Sport Club and those in the Junior and the Intro classes, finally £85 for GBMC members (thanks to a bequest from Gerry Thurlow). All entries must be made by the on-line entry system (the link can be found on the Club's website). Bank details will be provided once you have submitted your entry.

The maximum entry for the meeting is 75 plus 10 reserves and the minimum is 40. Should the minimum figure not be reached, the organisers reserve the right to cancel the meeting. Entries will be selected on a first come first served basis. Entry fees may be refunded upon notification to the Entries Secretary of the intention of withdrawal not less than seven days prior to the meeting. Should the event be cancelled for any reason whatsoever, the organisers reserve the right to retain £10 of the entry fee to cover administration costs.

16. **AWARDS** will be presented as follows:
- a) **FASTEST TIME OF DAY:** A Trophy and an award
  - b) Fastest in each class (ex FTD): An award (min of 3 in each class)
  - c) 2nd fastest in each class: An award (min of 5 in each class)
  - d) 3rd fastest in each class: An award (min of 10 in each class)
  - e) Best Green Belt MC member: An award

No competitor may win more than one award, apart from Best Green Belt MC member. Any additional awards may be specified in the Final Instructions. To qualify for the Best Green Belt MC award a competitor must have been a fully paid-up member of the Green Belt Motor Club before 1st July 2025.

17. Provisional results will be published as soon after the final run as possible. Protests and appeals should be in accordance with **NCR Ch. 6.1, 2.4, 2.9 and 2.10**. Final results may be available at the conclusion of the event; if not, they will be despatched to all competitors within 14 days.

19. SPECTATORS and DOGS are **NOT ALLOWED** at this meeting and a limited number of support crew members will be allowed, the actual number to be determined closer to the date and depending on the situation at the time and will be notified in the final instructions and by bulletins on the web site.



20. Venue Requirements

Any continual revving-up or exceeding 20mph in the paddock area or entering areas of the Airfield not allocated for the event may result in exclusion. Note: the perimeter road must be used to access the sprint area and the paddock but must be kept clear for other traffic at all times – do not block the road while waiting to compete as it is used by non-event personnel accessing the airfield facilities.

To enter the Airfield all vehicles will require a Vehicle Pass as supplied with the Final Instructions. All Competitors, Officials and Marshals must have one displayed on their vehicle on arrival.

21. Damage to Third Party Property

The Motorsport UK Insurance Policy does not cover any Circuit Damage. Should competitors cause damage to any third-party property they will be liable for the full reinstatement cost of any damage caused. Where the damage is covered by the Motorsport UK insurance policy, the competitor will be liable for the insurance excess that Green Belt Motor Club has to pay Motorsport UK, currently £475.

22. Final instructions, competition number, directions etc., will be forwarded to all competitors by email in the week prior to the meeting.
